LOAN PROGRAM Pineville United Methodist Church

The town of Pineville is located in the southernmost part of Mecklenburg County, and in 2005 the area had begun developing commercially. Members of Pineville United Methodist Church recognized that in all of the growth, there was no longer a good community meeting area. The congregation felt that the church had a call to be a community partner.


During this same time, Pineville UMC was running out of space. The church's fellowship hall was the largest meeting area, but they were in need of classrooms and a space suitable for hosting meals. The congregation took a step of faith, and decided to build what is now known as The Crossroads Center.

They started construction with one million dollars in pledges, and a loan from a commercial bank. In the summer of 2006 Rev. Tom Stinson-Wesley was appointed to Pineville UMC. Rev. Stinson-Wesley was familiar with the United Methodist Foundation of Western North Carolina from reports at Annual Conference and participating in programs sponsored by the Royce and Jane Reynolds Ministry Fund. He suggested that the church see if the Foundation's Loan Program could help. Shortly after, Pineville UMC refinanced their loan with the Foundation; borrowing \$1.4 millon with a 20 year term and lower interest.

As of 2019, Pineville UMC has hosted church events and houses a pre-school in The Crossroads Center. The facility has also been the home to various camps, Upward Basketball, and even serves as a community Polling Place during elections. The congregation has faithfully answered their call and continues to bless their community.

Today, the United Methodist Foundation of Western North Carolina would like to congratulate the Pineville United Methodist Church for paying off their loan in only 13 years! We celebrate the relationships that have been made and the lives touched at The Crossroads Center, and hope to continue to be your partner in ministry as we build the Church for generations to come!





FREQUENTLY ASKED QUESTIONS FOR CLIENT RELATIONS



There are a lot of questions your church may have before deciding to set up a Fund Management Account with the Foundation. Below you will find some of our most frequently asked questions about getting started.

What's the smallest/largest church you'll work with? We work with churches of all sizes, and are committed to providing excellent service to all.

What funds can we have managed?

We can manage any funds that are part of your ministry with a mid-to-long range time horizon – reserves, building, cemetery, missions, programs, endowments, etc.

I thought the Foundation only handled endowments?

Endowments are an important part of our ministry, but your funds do not have to be in an endowment for us to manage them for you.

Once we place funds at the Foundation, who owns them?

You do. We manage the funds as you direct us, but they remain under your ownership and control.

Do we have options for investment?

Yes. With a variety in our investment offerings, we are confident you will find the one that is right for your specific goals.

How do we create an investment account at the Foundation?

After you provide us with specific information, we set up a simple document, called an Investment Management Agreement, which outlines our commitment to manage your funds as you direct us. We create your account once we that document is signed and your funds are received.

How easy is it for us to change, add to, or withdraw from our investment?

It's as easy as picking up the phone, sending us an email, or dropping a letter in the mail. At your direction, the investment strategy can be changed.

Can we use our account like a checking account?

Because of the longer-range nature of investing, you'll be best served by keeping funds that you need highly-liquid (i.e.: your operations budget) in a checking account at a commercial bank.

FREQUENTLY ASKED QUESTIONS FOR FINANCIAL SERVICES

After setting up an account, you or a church committee may have questions for Financial Services. Some of the most frequently asked questions are below.

How do I request money from my account?

Send a letter on church letterhead (if applicable) that includes the account number and amount requested and has been signed by a church representative by:

When is the money available?

Checks are processed every Wednesday and a check will be mailed to the address on record. We also send funds via ACH on the 15th and last day of the month. Please contact us if interested in ACH transfers.

Who is authorized to request money from my account?

We realize that church staff and laypersons change, so we will accept a distribution request signed by any current authorized staff member or appropriate layperson such as the treasurer or finance team chair.

How do I receive statements for my account?

The easiest way to receive statements is to access them online. We will set up a user ID and password so that you can go online and access statements at your convenience. Please email Donna Johnson at djohnson@umfwnc. org if you would like to set up online account access. You will be given a user ID and password, along with instructions on how to access your account.

How do I deposit funds to my account?

How often is my account value updated?

Account transactions are updated every 1-2 business days and fund prices are usually updated by Tuesday of each week (except for holidays and month end).

How much can we spend from the account this year?

For endowment accounts the Foundation has a recommended spending policy of 4% of the average previous three years' December 31st fair market value. Please feel free to reach out to Donna Johnson at djohnson@umfwnc.org or Scott Lucas at slucas@umfwnc.org for assistance.

Finding the Perfect Gift

Jesus's words in Matthew 28:19-20 provide the Church with our mission, 'Go therefore and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything that I have commanded you.' As United Methodists, our stated mission, as outlined in The Book of Discipline, is to follow this great commission '... to make disciples of Jesus Christ.'"

You must clearly articulate how your program/initiative aims to make disciples of Jesus Christ.
You must submit a budget proposal indicating how all monies awarded will be used (monies must be used during calendar year 2020).
